**CONTRACT TO ASSUME RISK AND WAIVE LIABILITY**  
**EQUINE RELEASE, WAIVER, AND INDEMNIFICATION**

I, the undersigned participant, and his or her parent or legal guardian if the participant is under the age of 18 years, does/do hereby execute this release, waiver, and indemnification for himself/herself/themselves and his/her/their heirs, successors, representatives, and assigns, acknowledges the inherent risk involved in riding and working around horses.

I, \_\_\_\_\_, represent that I am an adult signing on my own behalf or on behalf of my minor child named \_\_\_\_\_, and that I wish (or my child or children) to ride, take lessons, and/or participate in horse related activities under the guidance and supervision of Abigail Segner/Abigail Kemper at any location and/or any escorted trips or functions sponsored by the above.

I fully understand that horseback riding (English or Western), regardless of the activity (riding in an arena, riding outside of an arena, riding over fences, other obstacles, steep or rough terrain, barrel racing, pole bending etc.) are very dangerous activities. I execute this waiver of my rights to sue and agree to assume all risks inherent in equine activities and have notice of all risks inherent in equine activities including:

- (i) the propensity of an equine to behave in dangerous ways i.e. running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in injury, harm, or death to persons on or around them,
- (ii) the inability to predict an equine's reaction to things such as sounds, movements, objects, persons, or animals, and
- (iii) hazards of surface or subsurface conditions and riding over unknown terrain where hazards may be hidden by vegetation or development,
- (iv) collisions with other animals or objects,
- (v) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.

I wish to participate in these activities knowing they are dangerous. I understand that riding horses and working in the stable area has inherent dangers, and that I or my minor child may be seriously injured, or even killed in a horse related accident. By way of illustration, a horse related accident includes being stepped on, kicked, or otherwise struck by a hoof, bitten, or a fall from a horse, etc. Equine activities are INHERENTLY DANGEROUS.

I understand that Abigail Segner/Abigail Kemper//Acrewood Hunters and 29 Acre Farm LLC cannot prevent accidents, and I do not expect them to do so. I have been specifically advised that I or my child may fall from a horse in the natural course of riding in any of the sponsored activities under the guidance of Abigail Segner/Abigail Kemper/Acrewood Hunters at any location including 29 Acre Farm LLC. If at any time while riding or in the stable's vicinity I or my minor child becomes fearful to the point I wish to dismount or leave the area, I or my child will advise my instructor or a representative of Acrewood Hunters.

I hereby specifically RELEASE, INDEMNIFY AND HOLD HARMLESS Abigail Segner/Abigail Kemper and Acrewood Hunters, as well as 29 Acre Farm LLC, its owners, agents, employees and their instructors from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) and negligence, except in the event of gross and willful negligence, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my participation in the recreational activities under the guidance of Abigail Segner/Abigail Kemper/Acrewood Hunters at any location and including 29 Acre Farm LLC or any claims which may arise out of me or my minor child's activities on or off the premises whether such damage, loss, injury, paralysis or death results from negligence of Abigail Segner/Abigail Kemper/Acrewood Hunters, or its owners, agents, or employees, or 29 Acre Farm LLC, or from some other cause. I AGREE that in signing this contract, I am binding myself, my survivors, or any other person or entity seeking to assert a claim on me or my minor child's behalf or which arises from an accident occurring under the guidance of Abigail Segner/Abigail Kemper//Acrewood Hunters at 29 Acre Farm LLC or at any location even if such accident results in permanently disabling injury or death to me or my minor child.

I have read this contract, understand it completely, and execute it voluntarily with full knowledge of its consequences.
